### PRIVACY ACT ACKNOWLEDGEMENT

**VALLEY WOMEN'S ASSOCIATION** (VWA) complies with federal and provincial privacy legislation and is committed to protecting our members' personal information. The information we collect is used to process memberships and to communicate with members via email/phone on a variety of issues of interest.

When you proceed with an online transaction a secure connection is established and your information is encrypted to prevent interception during the transaction. The secure connection is maintained until the transaction is complete or terminated.

VWA may gather data concerning traffic on the website for statistical analysis. This data is not linked to your personal information, and is used strictly to improve content of the site.

Our website may contain links to websites of other organizations that maintain their own privacy and security policies. This policy articulates the privacy practices of the VWA only.
